Purdue Phi Gamma Delta Class of 1955 Establishes Scholarship

Cifty years ago, the class of 1955 was Finitiated into Phi Gamma Delta. Today, many of us are retired doctors, dentists, college professors, business owners and executives. We think back on whom and what has influenced our lives. Phi Gamma Delta is on everyone's list. Yet, we remember two of our pledge brothers – John Bauerle '55 and Brook Bray '55 – who can't think back; they lost their lives serving in the military. The class of '55 has established a scholarship for a Purdue Fiji undergraduate in honor of our two fallen comrades as a lasting contribution and an appropriate memorial.

Our story begins in 1951 when 19 young men, fresh from high schools scattered across the Midwest, entered Purdue University and were fortunate enough to be asked to pledge Phi Gamma Delta. We were from smaller towns and suburbs – from middle class homes and with good, but not spectacular records in high school. Becoming pledges at a top fraternity at a major college was quite an eye-opening experience for us.

Although pledgeship was difficult, we soon discovered that the primary thrust

of it was our selfimprovement. We were criticized. chewed out and harassed, but at the same time were trained and counseled. We were expected to study (7:00 p.m. to 10:00 p.m. every school night), to participate in campus activities, to date and to have pride in our fraternity and our school.

We also learned to clean the house. We were taught to dress properly, eat properly and to develop social skills. It was a tremendous learning experience, made most effective by the leadership and example of the upperclassmen.

During our four years together, we developed friendships that we knew would last beyond college days. As we ventured into real life and scattered throughout the country, we kept in touch with a chain letter.

Most of us served our country in the military service. It was the military that cost us two of our beloved brothers: John Bauerle '55 and Brook Bray '55. Both were pilots and victims of training accidents.

After military service, our class continued to keep in touch as we completed graduate work, began our careers and raised families. Some of us were able to attend five-year reunions, others, due to family and career needs, were not able to do so. A few of our classmates drifted away. As we settled into middle-age, with our families and careers stable, thirteen of us decided to make a special effort to mark the 25th anniversary of our graduation with a reunion at Homecoming in 1980. We made it, had a great time and have repeated it every five years since.

Our class will meet once again in September in a very special reunion in Chicago to celebrate and pay honor to John and Brook. This reunion will not only include many of our brothers and their wives, but also John's widow and daughter and Brook's brother (a Michigan Fiji) and his wife. Afterwards, we will journey to West Lafayette for the 100th anniversary of the chapter and the 50th anniversary of our initiation into the fraternity of Phi Gamma Delta. The Class of '55 is a fine tribute to lasting friendships and the strength of fraternal bonds.




